Minutes of the 169<sup>th</sup> meeting of the Sydney Harbour Federation Trust held in public (in person and via webinar) on Thursday 14 December 2023.

#### In attendance

Members of the public and Harbour Trust staff members were in attendance (in person and via webinar) to observe the meeting.

The meeting commenced at 3.30pm.

#### 1. Welcome

- a) The Chair opened the meeting and welcomed attendees, and Ms Page delivered the Acknowledgement of Country.
- b) Due to their very recent appointments (on 28 November 2023), Ms Alex O'Mara and Ms Ann Sherry AO sent their apologies for being unable to attend today's Meetings of the Trust as they both had prior engagements.
- c) As there are now four new Members of the Trust (including the Chair), Members in attendance at the meeting introduced themselves and provided a verbal summary of their professional backgrounds. In their absence, the Chair read out the biographies provided by Ms O'Mara and Ms Sherry.

#### 2. Executive Director update

The Chair introduced Ms Janet Carding, Executive Director, who spoke to the presentation prepared for the meeting.

The presentation included:

- A high-level overview of all Harbour Trust sites, including their size, visitor numbers, tenancies, revenue earned and volunteer hours with information from the recently published Annual Report for 2022-23.
- Results of the recent tenant survey where it was pleasing to see that 90% of commercial and residential tenants would recommend Harbour Trust sites as places to visit.
- The official opening of the renewed Torpedo Factory at Sub Base Platypus took place on 15 September 2024, and was hosted by the Acting Chair, Ms Alison Page. The Hon Tanya Plibersek MP, Minister for the Environment and Water performed the ceremonial ribbon cutting. The official opening was well-attended by other elected officials Ms Zali Steggall OAM MP, Ms Kylea Tink MP and Ms Felicity Wilson MP. Also in attendance was the former Executive Officer of HMAS Platypus, Commander Sandy Coulson, CSM RAN Rtd.

A community event was held the following day, and last weekend an outdoor cinema experience was held at the site.

The Harbour Trust is hopeful that the Foreshore Parklands at Sub Base Platypus will be completed in March 2024 and opened for Easter, subject to no further latent conditions being found.

- Following the public consultation for the Middle Head / Gubbuh Gubbuh draft master plan, the architects and projects team have updated the plan with minor post-exhibition changes. The master plan was adopted by the Members of the Trust at their meeting earlier today.
  - The next steps are for the Harbour Trust to determine the staging for the project. There will be further public consultation where required.
- Public consultation on the North Head Sanctuary Draft Master Plan took place from 19 September 2023 to 31 October 2023. 71% of responses were supportive or very supportive of the draft master plan. The consultation outcomes report and responses will be published shortly and a final draft version of the master plan will be provided for Trust Members' approval in early 2024.
- Public consultation on the Cockatoo Island / Wareamah draft master plan closed yesterday. The consultation outcomes report will be finalised early in the new year.
- An update on the progress with capital programs, including works completed in 2023 and works to be completed in 2024. The Assets and Parklands team has approximately 96 projects underway. Photographs were shown of some of these works at North Head Sanctuary and Cockatoo Island / Wareamah; and the collapsed Greenway Wall at the Macquarie Lightstation for which restoration/conservation work is now on hold, pending the results of a referral under the Environment Protection and Biodiversity Conservation Act 1999.

#### 3. Meeting Closure

The Chair thanked Ms Carding for the presentation.

The meeting closed at 4.30pm and was followed by a question and answer session led by the Trust Chair.





## TENANT FEEDBACK SURVEY | COMMERCIAL AND RESIDENT LATER ALIGNMENT A

### Aim:

To assess and gauge tenant satisfaction, identify areas for improvement and enhance the overall landlord performance in managing our site.

### **Notable Outcomes:**

- 1. 90% of Commercial and Residential tenants are "extremely likely" to recommend the Harbour Trust as a visitor destination
- 2. There is an overall satisfaction rating of around 80% across both portfolios when dealing with the Property and Leasing Team
- 3. It is essential for the Harbour Trust to maintain our premises to a level that confirms our position as a competitor in the Commercial and Residential property market. We must ensure our service levels and offering answers the market needs.

## **Survey Numbers:**

128 commercial surveys sent by email November 2023 | 56 responses | 44% response rate 41 residential surveys sent by email November 2023 | 20 responses | 49% response rate





# Middle Head / Gubbuh Gubbuh Master Plan Update

## Where we are and next steps

- Consultation Outcomes Report and Responses published October 31 2023
- 55% of respondents were supportive or very of the revised draft master plan
- The architects and project team have updated the master plan to incorporate the feedback received from the public consultation
- Harbour Trust Board reviewed at 14 Dec meeting
- The project team will look at the staging and budget for the funded works of \$9.3m.
- Detailed design for Phase 1 of works will begin early
   2024 with further public consultation where required.


- 84 unique responses received






# North Head collapsed stone wall


- Straight section complete.

• All HAZMAT removal and demolition work complete


